## **Objective**

44 countries outside Europe now have data privacy laws, twelve of them in Asia – and we can add significant new Internet Regulations in China and Indonesia. Other Asain countries are developing privacy Bills, and in 2012 three countries brought in new laws and four others strengthened existing laws. Data privacy legislation is 'here to stay' in Asia, but the form it takes differs dramatically between countries.

You will be taken on a comprehensive exploration of the Asian jurisdictions with data privacy laws by Graham Greenleaf.

The focus of much of the world's commercial activity is shifting toward Asia, and data privacy compliance must now be part of any planning for this. Any business or agency representative, or their advisors, involved in activities or commerce in this dynamic region will be better equipped, after attending this workshop, to consider the risks and obligations of collecting, using or transferring personal data in, to or from these jurisdictions. Obligations of privacy compliance can arise in many ways.
